SECTION 4: First aid measures

4.1 Description of first aid measures

General notes

5. Paragraph 1(b) shall not apply to disposable textiles. 'Disposable textiles' means textiles that are designed to be used only once or for a limited time and are not intended for subsequent use for the same or a similar purpose.

6. Paragraphs 1 and 2 shall apply without prejudice to the application of any stricter restrictions set out in this Annex or in other applicable Union legislation.

"Ingredient" means any substance added during the process of formulation and present in the mixture for use for tattooing purposes. Impurities shall not be regarded as ingredients. If the name of a substance, used as ingredient within the meaning of this entry, is already required to be stated on the label in accordance with Regulation (EC) No 1272/2008, that ingredient does not need to be marked in accordance with this Regulation;
